The July meeting of the Emery County School District Board of Education, held at the School District Office, was called to order at 7:00 PM by Board President Laurel Johansen. Other Board members present were Marie Johnson, Sam Singleton, and Nanette Tanner. Superintendent Kirk Sitterud was also present. Board member Royd Hatt was absent and Jared Black, Business Administrator, was excused from the meeting.

Mrs. Johansen welcomed all in attendance and led the audience in reciting the Pledge of Allegiance.

**Board Action Item (B1)**: Board members considered the warrants, minutes and the June 2014 meeting, and financial reports for June 2014. A motion was made by Marie Johnson and seconded by Sam Singleton to approve the warrants, minutes and financial reports. The motion passed unanimously.

**Board Action Item (B2a):** Superintendent Sitterud recommended to the Board that the following individuals be approved for the positions indicated:

**Board Action Item (B2b):** Superintendent Sitterud recommended that the Board accept the resignation of Dixie Fielder as a counselor at Emery High School. Sam Singleton made the motion to accept Mrs. Fielder's resignation. The motion was seconded by Marie Johnson and passed unanimously.

**Board Action Item (B3):** A motion was made by Sam Singleton and seconded by Marie Johnson that Kirk Sitterud be appointed as the Superintendent of Schools for the Emery County School District for an additional two year term. Motion passed unanimously.

**Board Action Item (B4):** Superintendent Sitterud presented to the Board the annual Student Fee Schedule, as contained in Policy JQ-E, for approval. He indicated that the policy revision included the fees added by the Board in the June meeting as well as an additional \$10 fee for Emery High School for the A+ Credit Recovery Program. He indicated that students who completed the A+ Credit Recovery program would receive a refund of the fee paid.

A motion was made by Nanette Tanner and seconded by Sam Singleton to approve the Annual Student Fee Schedule (Policy JQ-E) as revised. Motion passed unanimously.

**Board Action Item (B5):** A motion was made by Marie Johnson and seconded by Sam Singleton to approve the District Medical Insurance Plan for 2014-15. The motion passed unanimously.

**Board Action Item (B6):** A motion was made by Nanette Tanner and seconded by Marie Johnson to approve the negotiated items with the Emery Education Association. A copy of the negotiated items is included in the minutes. Motion passed unanimously.
