MINUTES FOR AUGUST 25, 2021

REGULAR SESSION:

WORK SESSION (A):

- 1. President Johnson welcomed all in attendance
- 2. Jackie Allred along with KMA Architects presented the building plans for the currently designed Ferron Elementary and the future design of Emery High Building followed by an explanation of the bonding structure and funding for proposed projects. With the increased prices and constant construction challenges because of the covid-19 pandemic, the proposal is estimated to be higher than the original price. Several options were presented that included using Fund Balance, decreasing square footage of building, and the options of future taxes based on solar projects that have been approved.
- 3. A concern for the alien status of current workers on existing projects was answered with a confirmation letter from Westland Construction. It states that all employees that work on Emery School District projects under Westland Construction have followed all required documentation to report and maintain status with E-Verify (Homeland Security website). The letter was presented to the board and summarized to the attendees.
